# **Position Purpose**

The Knowledge Transfer Manager provides their professional expertise in knowledge and IP transfer to assist, support and advise MLA staff and will ensure maximum returns to the red meat industry, commercial partners and MLA investments by providing leadership in knowledge transfer activities.

Specifically, this involves working with the Manager, Knowledge & IP Transfer, IP Manager, Group Managers and research investment managers to:

- Improve MLA's impact to industry through best practise knowledge transfer and IP adoption practises, whilst adhering with MLA's strategic direction;
- Support MLA staff in the IP identification, evaluation, protection, and translation of ideas, research and technologies developed by MLA's R&D and Marketing investments;
- Promote effective and transparent IP governance processes and ensure adherence to delivery timeframes;
- Negotiate or support negotiation of other MLA staff, for translation and/or commercialisation terms, including preparation of term sheets and licence/commercialisation agreements;

- Providing ongoing training and mentoring to the business and partners on knowledge transfer, commercialisation and IP; and
- Build and maintain industry based commercial networks.

#### **Key Accountabilities**

This collaborative role will support MLAs Knowledge Transfer Team and will have extensive interaction with the R&D business units, marketing, contracts and legal teams, as well as, external service providers and commercialisers.

Some of the specific responsibilities will include the following:

- Develop, negotiate and finalise knowledge transfer agreements for new products. This includes the negotiation and development of IP, freedom to operate, licensing and royalty arrangements.
- Support the business by providing knowledge transfer and IP advice (particularly patents and trademarks).
- Ensure the Group Managers and investment managers are sufficiently advised and informed to make timely and appropriate decisions regarding IP management and knowledge transfer commercialisation matters.
- Oversee management, tracking and updating of executed licences towards, facilitating the strongest adoption of Australian products.
- Maintain, develop and ensure compliance of MLA's IP management plan.
- Assist in the ongoing development and implementation of MLA's Knowledge transfer Strategy.
- Assist in the development and mentoring of MLA staff to increase staff knowledge and skills in the areas of intellectual property, licensing and commercialisation.
- Ensure appropriate commercial terms and licences are implemented.
- Provide MLAs education and training to MLA staff.
- Ensure that MLA's policies and procedures are followed as applicable to self, other staff, contactors and all activities within area of responsibility and control.
- Grow MLAs simple licensing models, including creative commons & marketing tools.
